The Buccaneer Commission is one of the largest nonprofits to support education in the Coastal Bend. Proceeds from Buc Days and Rodeo Corpus Christi, as well as funds generated from endowments, are used for funding annual scholarships.

Committees

BBQ on the Bay

BBQ on the Bay Committee is a committee whose purpose is to support the Buccaneer Commission to help provide scholarships through fund-raising, providing volunteer services, and organizing and administering BBQ on the Bay events.

BBQ Cook-Off Sub-Committee

Requirements:

- Attend at least one committee meeting leading up to Buc Days.
- Assist with selling BBQ Teams for the five-day BBQ Competition.
- Attend the BBQ Team Captain meeting.
- Assist with recruiting BBQ Competition Judges.
- Be available for Load In on the Tuesday before the competition starts.
- Be available to assist with the Saturday BBQ competition.

Coastal Bend Showcase Sub-Committee

Requirements:

- Attend at least one committee meeting leading up to Buc Days.
- Assist with selling tickets for the 2nd Saturday BBQ on the Bay-Coastal Bend Showcase Competition.
- Be available for Load In on the Friday before the competition starts.
- Be available to assist with the BBQ on the Bay-Coastal Bend Showcase competition.

Buc Days Clays 4-H Shoot Committee (Spring Event)

The purpose of this committee is to host the annual Buc Days Clays 4-H Shoot. The 4-H Shoot Out Committee organizes and administers a youth clay target competition for Texas 4-H members. The purpose of the 4-H Shoot Out is to promote excellence in shooting sports and academic achievement through attention to education, commitment, and gratitude.

- Attending at least one committee meeting.
- Assist with setting up the shooting course.
- Attend event as a volunteer.

Buc Days Clays for a Cause Committee (Fall Event)

The purpose of this committee is to host the annual Buc Days Clays for a Cause. The clays tournament is designed to generate revenue to further the mission of the Buccaneer Commission.

Requirements:

- Attending at least one committee meeting.
- Commit to selling event sponsorships.
- Commit to selling a team for event.
- Assist with setting up the shooting course.
- Attend event as either a member of a team or a volunteer.

Coastal Bend Buyers Group

The mission of the Coastal Bend Kids Buyers Group is to recognize and reward kids for their hard work and dedication to their projects. Most importantly, it's about supporting the future of our agricultural community. By increasing the final bid, the Coastal Bend Kids Buyers Group aims to provide students with the means to fund their next project, advance their livestock operation, and contribute to their education fund. This is more than just a sale; it's an investment in the future.

Requirements:

- Attend Steak Night as a volunteer or as a attendee
- Sell at least table.

Community Engagement

Actively work within the community to build relations and raise awareness of Buc Days. Assist in organizing and facilitating Ag Awareness Days & STEAM Day.

Requirements:

- Attend at least two committee meetings.
- Participate in at least one Community Engagement Activity.

Competitions Committee

The purpose of the Competitions Committee is to host competitions to provide an impartial opportunity for youth to compete with their contemporaries while obtaining knowledge within their respective fields. Buc Days youth competitions include FIRST® Robotics Events, Culinary Competitions, and more.

Requirements:

- Attend at least two committee meetings.
- Participate in at least one shift during Buc Days.

Concessions Committee

The purpose of this committee is to support and staff beer tents and distribution of ice during the festival.

Requirements:

- Attend at least one committee meeting before the start of Buc Days.
- Have a firm understanding of partnership with distributors.
- Sign up in Volunteer Local to work a minimum of 4 shifts during the festival.
- Obtain a TABC server's license.

Golf Committee (Fall Event)

The purpose of this committee is to host the annual Buc Days Golf Tournament. The golf tournament is designed to generate revenue to further the mission of the Buccaneer Commission.

Requirements:

- Attending at least one committee meeting.
- Commit to selling event sponsorships.
- Commit to selling teams for event.

- Attend event as either a member of a team or volunteer.

Hospitality Committee

The Hospitality Committee cooks and serves lunch and dinner to corporate tents, volunteers, rodeo contestants and their families as well as others who are hard at work on the fairgrounds.

Requirements:

- Attend at least two committee meetings leading up to the festival.
- Have a firm understanding of the schedule and what each day requires.
- Sign up in Volunteer Local to work at least 4 shifts.

Corporate Tent Sales

Corporate Tent Sales is a Sub Committee of the Hospitality Committee, whose purpose is to support the Buccaneer Commission by providing quality service to the corporate team tents through the sale and delivery of beer and ice during BBQ on the Bay and Airshow events.

Requirements:

- Attend at least two committee meetings leading up to the festival.
- Have a firm understanding of the process of selling/delivering products and ice.
- Do not operate any equipment (golf carts, UTV, etc.) if alcohol has been consumed.
- Be available to assist with filling the first orders of product and ice.
- Sign up in Volunteer Local to work at least two shifts.

Leadership Program Committee

Members of the Leadership Program Committee assist in the activities to efficiently facilitate the Leadership Program application process. Duties include assistance in interviews, essay judging, providing support at Leadership Program events and Rodeo Corpus Christi.

Requirements:

- Attend at least two committee meetings.
- Sign up for minimum of two shifts of the following options: Essay Judge, Interviews Judge, Final Presentations Judge, Chaperone of Leadership Program event.
- Complete Conflict of Interest form.

Media Committee

The purpose of this committee is to foster community relations with external stakeholders through media relation activities. They will attend meetings and bring ideas and creative energy to the group, implement strategies as assigned and invite others to become involved.

Requirements:

- Escort/Host Media (Arena, Weather, Robotics, Outdoor Stage)
- Conduct Interviews (Treasure Island, Ticketing/Gates, Parades, etc.)
- Radio Station Remotes
- Assist VIP's
- Host Potential Sponsors and Visiting Groups (Miss Rodeo, Rumpchat)
- Host Photographers
- Attend two committee meetings per year

Membership Committee

The purpose of this committee is to promote Buc Days through the sale of annual memberships to interested individuals to support the Buccaneer Commission.

Requirements:

- Attend at least two committee meetings.
- Sign up to work the Membership Lounge two shifts during Buc Days through Volunteer Local.
- Assist in the recruitment and retention of Buc Days Members.

Merchandise Committee

The Merchandise Committee sells the official Buc Days and Rodeo Corpus Christi merchandise during the event. Volunteers also sell Entertainer Merchandise for the Rodeo Concert Series.

Requirements:

- Attend at least two committee meetings.
- Sign up for set up and/or tear down of merchandise booths.
- Sign up to work at least two shifts during Buc Days through Volunteer Local.

Operations Committee

The purpose of this committee is to support all committees of Buc Days logistically through setup, execution of, and completion of each committee's respective events.

Requirements:

- Willingness to work outside in the elements.
- Able to safely perform physical activities.
- Attend scheduled Saturday "All Committee" workday in March to help prepare for event.
- Sign up in Volunteer Local to work at least two shifts during five day set up period.
- Sign up in Volunteer Local to work at least two "on call" shifts during festival.
- Sign up in Volunteer Local to work at least one shift during break down period.

Outdoor Entertainment Committee

The Outside Entertainment Committee members host and manage the Beer & Wine Garden Stage, Buckin' Marlin Stage and History Exhibit during the run of Show.

Requirements:

- Attend at least one committee meeting prior to Buc Days.
- Sign up for set up and/or tear down of outdoor entertainment areas and History Exhibit.
- Sign up for at least two shifts during Buc Days through Volunteer Local.

Parades – Bucaraders – Must be a member of the Bucarader organization.

The Bucaraders are responsible for organizing and positioning parade participants for the Night Parade and Children's Parade. They work closely with public officials, ensure safety on the parade route and provide parade marshals along the route.

Requirements: Bucarader organization has its own policies and procedures.

Rodeo Corpus Christi Committee

The purpose of the Rodeo Committee is to provide a fair and safe environment for contestants and world class entertainment for fans. The Rodeo Committee also proactively communicates with participants to ensure the animals' health and well-being during the Rodeo.

Requirements:

- Sign up for one full day of set up
- Sign up for two rodeo performances
- Immediately following Saturday night performance work teardown

Shops at Treasure Island Committee

The purpose of this committee is to make all food and commercial vendors, Shops at Treasure Island vendors and attractions feel welcome, as well as assist with their needs during the festival.

Requirements:

- Attend at least one Shops at Treasure Island committee meeting prior to Buc Days.
- Sign up for at least two shifts during Buc Days through Volunteer Local.
- Sign up to assist with Load In and/or Load Out through Volunteer Local.

VIP Committee

Committee members are responsible for the operations of all VIP areas during the festival. Including setup, inventory control, equipment maintenance and enforcement of the Festival's responsible alcohol management program. Additionally, their duties include acting as hosts during some official functions.

Requirements:

- Attend at least two committee meetings.
- Mandatory participation of either one VIP setup day or one teardown day.
- Participate in minimum of two VIP shifts during Buc Days.

Membership General Policies and Procedures

The deadline for application is April 1st preceding Buc Days and Rodeo Corpus Christi (collectively, "BUC DAYS"). Late applications will not be guaranteed all privileges, i.e. Season Festival Grounds Passes, committee badge and parking pass. Memberships may not be transferred or reassigned. Memberships are non-refundable. The term of annual memberships shall be calendar year, August 1 – July 31. Renewal of membership will be due annually. Parking in designated lots is limited and not guaranteed. We recommend that members arrive early to obtain preferred parking. Overflow parking will be directed to general public lots.

Copies of the Volunteer Membership Application, the Release of Liability, Indemnity, and Background Check Authorization Agreement, and the rules, regulations and policies of BUC DAYS, including the General Membership Policies and the Volunteer Handbook, as they now exist and are available on the BUC DAYS website. If accepted as a member of the BUC DAYS, I agree to abide by all of such Rules, Regulations, and Policies of the BUC DAYS as they now exist or as it may be revised by BUC DAYS. Should I violate any such Rules, Regulations, and Policies, I agree to RELEASE, INDEMNIFY and HOLD BUCCANEER COMMISSION HARMLESS against any claims that are made against BUCCANEER COMMISSION arising out of or related to any such violations of the Rules, Regulations and Policies by me.

It is the Policy of BUC DAYS for all BUC DAYS personnel to avoid conflicts of interest and potential conflicts of interest in all dealings involving BUC DAYS. Towards that end, the Commissioners of BUC DAYS hereby adopts the following Policies and Procedures. At no time will any volunteer be permitted to carry a firearm on the BUC DAYS festival grounds or at any event hosted by BUC DAYS. It is against BUC DAYS policy for any volunteer to act with inappropriate behavior, including but not limited to, stealing, harassment of any kind, and public intoxication. BUC DAYS reserves the right to deny and/or revoke any membership. BUC DAYS has adopted a policy requiring members and volunteers to authorize BUC DAYS to perform criminal background checks in accordance with BUC DAYS Criminal Background Check Policy and the Release of Liability, Indemnity, and Background Check Authorization Agreement. BUC DAYS reserves the right to administer a criminal background check on any volunteer.

Code of Ethics Acknowledgement

- I. Introduction
 - i. Purpose – The reputation for fairness and excellence depends on the collective commitment of our directors, officers, committee members and employee family working together in a manner that merits trust and confidence from our customers, communities, and most importantly, the youth we serve. The purpose of this document is to convey those basic principles of conduct.
 - ii. Objective – The primary objective of this document is to reinforce accountability for responsible and mature behavior in all who represent our organization.
- II. Standards of Conduct
 - i. All persons professionally associated with our organization are expected to adhere to the spirit and letter of all laws, rules and regulations.
 - ii. Illegal or unethical actions are unacceptable and willful violations of the substance, intent or implementation of this document will be grounds for appropriate disciplinary action.
 - iii. Each employee or volunteer must manage business affairs so as to avoid situations that might lead to conflict or even suspicion of conflict between one's self-interest and one's obligations to our organization or its customers.
 - iv. An individual's position must never be used, directly or indirectly, for private gain, to advance personal interests or to obtain favors or benefits for himself/herself or a member of his/her family.
 - v. Each employee or volunteer must keep the interest of Buc Days foremost in mind while providing assistance to spectators, performers and participants of Buc Days events.
 - vi. Each employee or volunteer must give, to the best of his/her ability, comprehensive and thorough support of the respective committee membership.
 - vii. Each employee or volunteer must acknowledge and support the proper and authorized uses of Buc Days equipment and resources.
 - viii. Each employee or volunteer must thoroughly understand the needs of the respective committee before proceeding with recommendations.
 - ix. Each employee or volunteer must be honest and trustworthy, avoid harm to others, be fair and not discriminate and respect the privacy of others.
 - x. **Each employee or volunteer must avoid the consumption of alcoholic beverages before coming on duty and while on duty.**
 - xi. Each employee or volunteer must avoid making financial commitments for Buc Days without advance approval by the Buccaneer Commission CEO.
 - xii. All statements to the media are to be made only by the CEO, unless otherwise designated by the CEO.
- III. Monitoring the Code of Ethics
 - i. Responsibility, with commensurate authority for communicating and assuring compliance of the Code of Ethics, is placed with the CEO, Buc Days staff and Committee Chair. The Governing Board of the Buccaneer Commission shall act as a peer review committee to review any instance of misconduct, impropriety, or the appearance of either.
