BUC DAYS 2021 PARADE VENDOR GENERAL RULES

Prohibited Items

No Parade Vendor may sell the following items identified by the Police Chief: silly string, or any similar squirting device; poppers or any similar noise device; stink bombs or smoke bombs, or any similar device; or lasers or any similar laser producing device. No alcoholic beverages may be sold by a Parade Vendor.

Food and Beverage Requirements

- All Food and Beverage Vendors shall comply with all requirements of the Nueces County Public Health Department, and all other local, State or Federal laws, rules, and regulations regarding the sale and storage of food.
- All food and beverage parade vendors shall clean the area around each food and beverage booth. The cleanup will be hourly and immediately after the conclusion of a Parade Event.

Clean Up

All food and beverage vendors shall clean a designated zone adjacent to their respective booths at regularly scheduled intervals. The cleanup will be hourly and immediately after closing the Event each day. All trash cleaned up must be properly deposited in a trash bag. Littering violations shall be enforceable by authorized City employees under applicable City ordinances.

Access

- Night Parade Vendors may be permitted along the parade route during and for six to eight (6-8) hours prior to and one (1) hour after parade on parade day (5/02/21)
- Junior Parade Vendors may be permitted along the parade route beginning after 8:00am on parade day (5/08/21) and one (1) hour after parade.
- Parade Vendors shall be restricted in their location to sidewalks and other public areas, except streets, immediately adjacent to and within six hundred (600) feet of the parade route and to private premises immediately adjacent to and within six hundred (600) feet of parade routes.

Other

- **Vendor fees are non-refundable (no exceptions).**
- Attendance of parades are not guaranteed.
- Vendor profit is not guaranteed.
- Vendor should be prepared for all types of weather conditions (ie: rain, strong wind, etc.)
